



SWEEPSTAKES RULES

The following are the official rules for the Holiday Shopping Contest (the "Promotion"). This promotion is sponsored by Social5 ("Sponsor"), 13961 S. Minuteman Dr, Draper, UT 84020. Sponsor is offering the Promotion through and on behalf of a select group of its customers. The customers of the Sponsor offering the Promotion shall be the "Hosts". The individual customer through which you received contact about the Promotion is the "Host". You will know the identity of the Host through the method by which you received notice of the Promotion (i.e. the Host's website, Facebook page, or email). Together the Sponsor and Hosts are the "Promotion Entities".

How to Enter: Beginning at 12:00 p.m. Eastern Time ("ET") on November 18, 2019 until 11:59 p.m. ET on December 11, 2019 (the "Promotion Period"), you may enter the Promotion by accessing the Promotion Facebook Application (the "Facebook Page"); filling out the information requested by the Promotion entry form (the "Entry Form") provided under the sweepstakes tab on the Facebook Page; and submitting the Entry Form by clicking "submit". Incorrect and incomplete entries are void. Becoming a fan of the Host page on Facebook does not constitute an entry into the Sweepstakes. Entrants understand that they provide their information to the Host.

Limit of one (1) entry per eligible person during the Promotion Period. Multiple participants are not permitted to share the same email address. Any attempt by you to obtain more than the permitted number of entries by using multiple/different email addresses, identities, registrations or logins, or any other methods may void your entries and you may be disqualified from the Promotion. In the event of a dispute as to any online entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holders.

This Promotion is valid only in the United States, excluding Rhode Island. Void where prohibited by law. Except where prohibited, participation in the Promotion constitutes your consent to Sponsor's use of your name, likeness, entry, and state of residence for promotional purposes in any media without further payment or consideration.

Limitations of Liability: The Promotion Entities their respective affiliates, subsidiaries, parent, advertising and promotion agencies, and their respective officers, directors, shareholders, employees and agents, and any and all Internet servers and access provider(s) are not responsible for: any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer online systems, computer equipment, server providers, or software, including any injury or damage to your or any other person's computer relating to or resulting from participation in this Promotion; inability to access the Website or Facebook; theft, tampering, destruction, or unauthorized access to, or alteration of entries; transactions that are processed late or incorrectly or are incomplete or lost due to computer or electronic malfunction or traffic congestion on the Internet or at any web site; printing or human or other errors; and any entries which are late, lost, incomplete, misdirected, stolen, or any combination thereof. Online submission is not considered proof of delivery or receipt. All entries become the property of Sponsor and will not be returned. By entering, you agree to release, discharge, indemnify and hold harmless the Promotion Entities and their respective parent companies, subsidiaries, their respective representatives and agents, advertising and promotion agencies, promotion partners and prize suppliers, and all of their respective affiliated companies, employees, officers, directors and shareholders, from and against all claims and damages or liability arising in connection with your participation and/or entry in the Promotion and/or their receipt or use of any prize awarded in this Promotion or due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in any Promotion-related activity or participation in this Promotion. Sponsor's decisions with respect to the winner and other matters pertaining to the Promotion shall be final. The winner may be required to sign an affidavit of eligibility and release of liability and publicity (where permitted), and return same, properly executed, within five (5) days of issuance of prize notification. If Sponsor is unable to contact the Grand Prize Winner within 24 hours of first email notification attempt,

Sponsor will attempt to contact through a second email notification. If the winner cannot be reached within 48 hours, or if the winner fails to complete and return all requested forms by the specified date, or if the winner fails to comply with any of the requirements, his/her prize will be forfeited and an alternate prospective winner shall be selected. Should the Promotion be terminated prior to the stated expiration date, notice will be posted on the Website. In the event of a dispute as to the identity of the winner based on an e-mail address, the winning entry will be declared made by the authorized account holder of the e-mail address submitted at time of entry. The specifics of all aforementioned elements of the prize in the Promotion shall be solely determined by Sponsor. All costs, taxes, fees, and expenses associated with any element of any prize not specifically addressed above are the sole responsibility of the respective winner. Winner may be required to complete and return any tax forms necessary for Sponsor to produce the 1099.

You agree to service of process by mail or other method acceptable under the laws of the State of Utah.
